

Alliance Denver Legal Release

✓, the undersigned, understand that *BFM Live Entertainment, LLC, WRP, LLC, and Alliance LARP - Denver* (collectively known as “the Sponsors”) have taken all precautions and reasonable steps to minimize all risks (including COVID-19) to participants but is unable to completely guarantee that no injury will come to me. I understand that the events coordinated by the Sponsors consist of a live-action role-playing game, including mock combat with foam weapons and padded projectiles, in an outdoor wilderness setting. I understand the risks involved in participating in the events coordinated by the Sponsors.

✓ confirm that I am in good physical health and do not suffer from any physical disabilities unknown to Alliance LARP. I agree also to the following restrictions placed upon me by Alliance LARP:

- I will not use the padded weapons approved by Alliance LARP unless I have first been instructed in their proper use through safety training;
- I will not bring or consume alcoholic beverages, recreational marijuana, or any illegal drug during any event;
- I will not use any skills taught by Alliance LARP for illegal purposes;
- I will not charge admission to any event I may hold using the rules of Alliance LARP, nor will I claim to be a subsidiary or representative of Alliance LARP; unless authorized to do so by contract with Alliance LARP.
- I will at all times abide by the safety rules of Alliance LARP.

✓ shall make no claim of any description against the organization, members or officers of the Sponsors, or any company doing business with the organization for any loss or damages suffered in the course of participating.

1. **Waiver and Release:** I, the undersigned, release and forever discharge and hold harmless the Sponsors and their successors and assigns from any and all liability, claims, and demands of whatever kind or nature (to include Covid-19), either in law or in equity, which arise or may hereafter arise from my participation in events coordinated by the Sponsors. I understand and acknowledge that this Release discharges the Sponsors from any liability or claim that I may have against the Sponsors with respect to bodily injury, personal injury, illness (to include Covid-19), death, or property damage that may result from my participation in an event coordinated by the Sponsors
2. **Medical Treatment:** I hereby Release and forever discharge the Sponsors from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my participation in an event coordinated by the Sponsors
3. **Assumption of Risk:** I understand that the Sponsors have taken all precautions and reasonable steps to minimize all risks to participants but are unable to completely guarantee that no injury or illness will come to me. Since the events are mainly conducted outdoors in wilderness areas, there is always the possibility of a slip-on rough ground, a fall over obstacles in darkness, or the occurrence of some other unforeseeable accident. Further, since I may also be participating in mock battles using padded weapons, there is a risk of injury from other participants. As a participant, I hereby expressly assume the risk of injury or harm from these activities and Release the Sponsors from all liability for injury, illness, death, or property damage resulting from my participation in an event coordinated by the Sponsors.
4. **Photographic Release:** I grant and convey to the Sponsors all right, title, and interests in any and all photographs, images, video, or audio recording of me or my likeness or voice made for or by the Sponsors during the course of my participation in an event coordinated by the Sponsors.

5. Other: As a willing participant in an event coordinated by the Sponsors, I expressly agree that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Colorado and that this Release shall be governed and interpreted in accordance with the laws of the State of Colorado. I agree that in the event that any clause or provision of the Release is deemed invalid, the enforceability of the remaining provisions of this Release shall not be affected.

6. Indemnification: To the extent permitted by law, I agree to indemnify and hold harmless the Sponsors from and against any and all loss, costs, claims, damages, liabilities, suits, liens, and expenses (including reasonable attorney fees and costs of defense) incurred by or asserted against the Sponsors directly or indirectly arising or alleged to arise out of or in connection with or due to my participation in any event coordinated by the Sponsors.

I understand that failure to abide by these agreements could result in expulsion from the Alliance LARP or in the extreme to legal action.

By my signature, I confirm that I have read this release, understand its terms, and agree to its provisions. I understand that this form affects my legal rights.
